Chris St. Germaine, Local Partnerships Manager of Ziply Fiber presented information on the Oregon Capital Project Fund (CPF Project). Ms. St. Germaine advised she is requesting a letter of support for a grant application to obtain a portion of the CPF Project funds for Wallowa County. Conversation ensued discussing the difference between areas in the county which are unserved and underserved in internet access. Ms. St. Germaine discussed with the Commissioners specific areas of the county they are targeting and the timeframes of completing updates to access. At Commissioner Roberts' request, Ms. Germaine agreed to supply a template for a letter of support.

Commissioner Nash mentioned an upcoming Wolf Depredation Training for our Sheriff and a few others. The last training for Sheriffs was in 2017 at Malheur County. Wallowa County has the opportunity to offer a contribution to offset some of the costs. Total costs of the event are unknown as of

now, depending in part on if lunch is provided for attendees. Mr. Jones is not asking for compensation for the training, but it would be good to provide him with travel costs. The date of the training is set for January 16, 2024. The Commissioners will consider their contribution at the next regularly scheduled meeting, December 6, 2023.
