Weed Board Presentation – Andy Marcum, Wallowa County Vegetation Manager, Gavin Carman, Tri-County CWMA, Beckijo Smergut-Wall, Wallowa-Whitman National Forest, and Marci Schreder, Wallowa Resources presented the annual Weed Board Update highlighting accomplishments of 2023 and plans and goals for 2024 (see PowerPoint pages, attached).

Commissioner Nash thanked those involved and expressed his appreciation for the work they do.

Eastern Oregon Mining Association Membership – Commissioner Nash advised membership is approximately \$80/year. Wallowa County does not have any active mines. Commissioner Roberts read a portion of the Mining Association goals addressed in the letter. Not seeing a benefit of the membership to the citizens of Wallowa County.
